#### **ORDINANCE NO. 525**

# AN ORDINANCE REZONING AN AREA WITHIN THE CITY OF ONAWA, IOWA FROM MOBILE HOME DISTRICT (MH) TO ARTERIAL COMMERCIAL DISTRICT (AC)

# BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF ONAWA, IOWA:

WHEREAS, the owners of property described as follows:

All that part of the Southwest Quarter of the Northwest Quarter and the Northwest Quarter of the Southwest Quarter of Section 9, Township 83 North, Range 45 West of the Fifth Principal Meridian, Monona County, Iowa, described as follows:

Beginning at the Northwest Corner of the Southwest Quarter of Section 9-83-45, thence South 00° 37' 53" West 100.00 feet along the west line of said Southwest Quarter, thence North 89° 44' 15" East 204.22 feet, thence North 00° 02' 13" East 94.79 feet, thence South 88° 55' 45" East 125.00 feet, thence South 00° 02' 13" West 91.89 feet, thence North 89° 44' 15" East 195.05 feet, thence North 00° 01' 28" East 474.78 feet, thence North 88° 54' 57" West 523.00 feet to point on the west line of the Northwest Quarter of said Section 9-83-45, thence South 00° 02' 04" West 387.08 feet along said line to the Point of Beginning. Said parcel contains 5.51 acres, more or less, including the presently established road right-of-way;

(locally known as 1735 10<sup>th</sup> Street)

in the City of Onawa, Monona County, Iowa (the "Property") requested zoning change for the Lots from mobile home district (MH) to arterial commercial district (AC); and

WHEREAS, the Planning and Zoning Commission considered the request, after public hearing, and has made a recommendation to approve the zoning change; and

**WHEREAS**, prior to amending or changing the zoning, a public hearing is required under Iowa Code §414.4; and

WHEREAS, pursuant to Iowa Code §414.5, a written protest may be filed with the City Clerk by the owners of twenty percent (20%) or more of the area of lots included in the proposed zoning change, or by the owners of twenty percent (20%) or more of the property which is located within two hundred (200) feet of the exterior boundaries of the property for which the change is proposed. The protest must be filed before or at the public hearing; and

WHEREAS, a properly filed written protest would require a favorable vote of at least three-fourths of all members of the Council to approve the zoning change; and

WHEREAS, notice of the public hearing was properly published in the newspaper and provided to the property owners; and

WHEREAS, after comment and consideration of objections by the public, if any, the Council believes the rezoning is in the best interest of the City of Onawa and is reasonable for the character of the area of the district and the suitability of such area for the particular uses; and

WHEREAS, Council has considered the smart planning principles under Iowa Code §18B.1.

**NOW THEREFORE, BE IT ORDAINED** by the City Council of the City of Onawa, Iowa as follows:

- 1. The above-described Property is rezoned from mobile home district (MH) district to arterial commercial (AC) district.
- 2. The official zoning map of the City of Onawa shall be amended to note the change in classification.
- 3. If any section, subsection, sentence, clause, or phrase of this Ordinance, for any reason, is held to be unconstitutional, such shall note affect the validity of the remaining portion or portions of this Ordinance. The City Council of Onawa, Iowa hereby declares that it would have passed this Ordinance, and each section, subsection, sentence, clause, or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses, and phrases be declared unconstitutional.
- 4. This Ordinances shall be in full force and effect after its final passage, approval, and publication as provided by law.
